1. Tuition-free/debt-free higher ed movement: Constance Penley

The Coalition to Reclaim California's Master Plan for Higher Education, with its <u>\$66 Fix</u> policy paper, gained new momentum when progressive Democratic Presidential primary candidates made debt-free and tuition-free higher education policies part of the national conversation. To take advantage of new federal funding of higher education, states will have to create matching funding streams, as happened (or not) with the Affordable Care Act, for example. While in need of tweaking and updating, California's Master Plan, the original "College for All" proposal from 1960, provides a template for states to renew their commitment to accessible, quality public higher education. In February, CUCFA will present The \$66 Fix to CA state legislators and their staff. Hosted by the Progressive Democrats of America (PDA), the meeting aims to find a legislator to sponsor a bill. 3. Increasing solidarity with the unions: Mia McIver and Claudio Fogu

CUCFA is committed to supporting the UC-AFT in their fight for job stability for lecturers. Mia McIver noted that it is more crucial than ever for cross-rank solidarity - tenure is not guaranteed for TT faculty. She shared a <u>link</u> to current erosion of tenure protections at the University of Kansas.

4. UC's leadership in the Green New Deal: Adam Aron

Adam Aron represented the UC Green New Deal/climate action and justice movement: UC should get off of fossil fuels as a major step as the 3rd leading employer in California, the 5th largest economy in the world. GND is calling for a fossil free UC–fossil free energy systems and fossil free finance. They advocate changing the goal from neutrality to fossil free (decarbonize) and more transparency for the fossil free finance claim. There was important discussion during the session about the problems with electrification, which had to be cut short due to time. 5. Role of Faculty in Decision-Making Around Use of Private Technology Platforms

Concerns with online teaching and use of surveillance technologies like Zoom and ProctorU were also raised. This is something to keep an eye on, as the Regents and the Governor seem to be advocating much greater use of online teaching after the pandemic. SBFA members Jennifer Holt and Claudio Fogu have spearheaded the protests about UC's outsourcing of our teaching mission to unaccountable private tech platforms that do not guarantee privacy, student data security, faculty control of content, or academic freedom. 7. Furloughs, Austerity Measures

Furloughs have not been as progressive as hoped for where they have taken place (UCB's Sharad Chari and Paul Fine reported on this) and we are concerned about whether and how UCOP plans to support faculty (including non-senate lecturer colleagues) through a pandemic.

8. Fallout from Campaign for Graduate Student Cost of Living Increase

COLA (the graduate student movement for a cost of living adjustment/general liveable wage at the UCs) continues. One of the student activist leaders involved in the COLA strike at UCSC remains suspended even after the Student Conduct Board recommended against it.
